END USER LICENSE FOR PRODUCTS OF TIMEGATE INSTRUMENTS LTD

This End User License Agreement applies to all Software Products of Timegate Instruments Ltd. (VAT number FI26156492) incorporated under the laws of Finland ("Timegate Instruments").

By downloading and installing, copying, or otherwise using the Software Product (as defined later), or clicking an "accept" button or a logical equivalent, you are binding yourself and the business entity you represent (hereinafter collectively "You") to the terms and conditions of this end user license (hereinafter "EULA") including the warranty disclaimers and limitations of liability provisions below. If You do not agree to the terms and conditions of this EULA, do not download, install, copy, or otherwise use the Software Product and destroy or return the Software Product, all copies and accompanying documentation thereof to Timegate Instruments. YOU AGREE THAT YOU HAVE READ THIS EULA AND UNDERSTAND AND AGREE TO BE BOUND BY ITS TERMS.

1 Product Definition

As used in this EULA, the term "Software Product" means all software products of Timegate Instruments including TGLab M3, M3 Batch Process, and M3 SW updater as well as M3 Software Development Kit ("SDK") including the software, software development kits, libraries, application programming interfaces, sample code, templates, tools, plugins, and other related materials Timegate Instruments may make available to You for use in connection with Your development of applications, in object code form, or any part thereof, and any and all printed, online and/or electronic documentation related thereto (hereinafter "Documentation"), modifications, additions, updates and upgrades that do not change the overall utility, functional capability or application of the Software Product (hereinafter "Upgrades").

2 License Grant

The Software Product is licensed, not sold by Timegate Instruments. Subject to compliance with the terms and conditions of this EULA and the applicable laws in force in the jurisdiction where the Software Product is used, Timegate Instruments hereby grants You solely for the term of this EULA, a limited, revocable, non-exclusive, non-transferable license, without rights to sublicense, to download, install and internally use a copy of the object code version of the Software Product solely on or directly in connection with the use of equipment provided by Timegate Instruments.

The SDK is provided for integration of an M3 device with a 3rd party application. The SDK may be used to perform operations on measurement files produced by the PicoRaman M3. You may only use the SDK to develop applications, strictly for Your own internal use, in connection with your use of the PicoRaman M3 product. You

may not use this SDK to develop applications for other platforms or for third parties or to develop another software development kit or other software products.

3 License Limitations and Restrictions

You have the right to make one (1) machine-readable copy of the Software Product for back-up or archival purposes provided that archival or back-up copy is not installed or used on any computer.

You are not entitled to a) disclose, sell, rent, lease, time share, market, commercialize, sub-license or otherwise assign, transfer, disclose or distribute the Software Product; or b) otherwise use the Software Product or information derived from the Software Product in any manner inconsistent with or not expressly permitted under this EULA.

You are not allowed to circumvent any technical measure, modify, alter, adapt, translate, reverse engineer, reverse compile, disassemble, decompile, or otherwise attempt to discover or derive source codes, algorithms, or underlying ideas from the binary code of the Software Product except to the extent expressly permitted under the applicable mandatory law or create any derivative work based on the Software Product.

4 Copyright and Other Intellectual Property Rights

The Software Product and all rights, including without limitation intellectual property rights therein, are owned by Timegate Instruments and/or its licensors. The structure, organization, algorithms, and code of the Software Product are valuable trade secrets and confidential information of Timegate Instruments and/or its licensors.

“Intellectual Property Rights” means any and all patents, copyrights, trade secrets, trademarks, tradenames, and any and all other intellectual property and proprietary rights. Timegate Instruments reserves all rights not expressly granted to You and You may not use the Software Products for any purpose not expressly permitted by this EULA.

5 Technical Support not included

Timegate Instruments has no obligation to provide any technical support services under this EULA. This EULA does not give You any rights to any Upgrades to the Software Product or to any extensions or enhancements to the Software Product developed by the Timegate Instruments at any time in the future. Timegate Instruments has no obligation to furnish You with technical support services unless separately agreed in writing.

Timegate Instruments may from time to time at its sole discretion provide Upgrades with error corrections, bug fixes and possible new features to the Software Products. If You have a valid license or a valid maintenance agreement You may be provided with such Upgrades if and when they are made available by Timegate Instruments. Your rights granted under this EULA terminate automatically without further notice from Timegate Instruments if You fail to comply with any terms or conditions of this EULA.

Timegate Instruments may terminate this Agreement immediately if You fail to make any payments to Timegate Instruments when due under any agreements between Timegate Instruments and You, or if You are in breach of this Agreement.

In the event of termination, You must destroy or return at Your own cost the Software Product, including all back-up copies and related documentation provided by Timegate Instruments.

The arbitration shall be conducted in Helsinki, Finland, in the English language. The award shall be final and binding on the parties.

You may not export or re-export the Software Products except in compliance with applicable export controls laws, sanctions, regulations, executive orders, treaties, and other agreements in force from time to time relating to the export, re-export, and import.

11 Changes to the EULA

Timegate Instruments reserves the right to change this EULA at any time in its discretion. We will give you notice of the changes by posting an updated version of this EULA online. Changes will be effective as of the date we post them, unless we specify a different effective date when we make a particular change. You are responsible for checking for EULA updates.
